OFFICIAL RULES

[CAMPAIGN_TITLE] Promotional Sweepstakes

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- 1. Sponsor.** [ENTITY_LEGAL_NAME], [ENTITY_ADDRESS] ("Sponsor"), operator of drawadraw.com.
- 2. Promotion period.** Entries are accepted from [START_DATETIME_ET] until the earlier of [END_DATETIME_ET] or the moment the edition supply of [SUPPLY_CAP] is fully collected ("Early Close"). The end time never extends.
- 3. Eligibility.** Open to legal residents of [ELIGIBLE_JURISDICTIONS] who are 18 years or older (19+ in AL/NE, 21+ in MS, if included). Employees and contractors of Sponsor, its artists, vault and logistics partners, and their immediate households are not eligible. One person may hold at most [ENTRY_CAP_PER_PERSON] entries across ALL entry methods combined.
- 4. How to enter.**
 - (a) With a purchase of a collectible edition.** Each \$[TICKET_PRICE] numbered digital edition of "[ARTWORK_TITLE]" purchased on drawadraw.com includes [ENTRIES_PER_TICKET] promotional entry(ies). The edition is a product with independent value; the entry is a free promotional bonus.
 - (b) Free mail-in entry (AMOE), identical odds.** Hand-print your full name, mailing address, email, and (optionally) an Ethereum wallet address on a 3x5 card and mail it in a first-class-stamped envelope to: [AMOE_PO_BOX_ADDRESS]. One card per envelope; limit [AMOE_LIMIT_PER_PERSON] mail-in entries per person. Mail-in entries must be postmarked by [AMOE_POSTMARK_DEADLINE] and received by [AMOE_RECEIPT_DEADLINE]. Mail-in entries carry exactly the same odds per entry as purchase entries, are recorded in the same entry ledger, and count against the same per-person cap.
- 5. The entry ledger and draw.** All entries from both methods are recorded in a single append-only, hash-chained ledger. At close, the complete ledger is frozen and its Merkle root is committed to the Ethereum blockchain (contract [REGISTRY_ADDRESS], campaign #[CAMPAIGN_ID]). The winning entry is selected by Chainlink VRF public randomness applied to the frozen ledger by the published deterministic rule: winning index = first random word modulo total entries; alternates follow in word order. No person exercises discretion over the selection. Anyone may verify the draw from public chain data at drawadraw.com/campaigns/[CAMPAIGN_ID]/audit. The draw occurs and the prize is awarded regardless of the number of editions sold.
- 6. Prize.** One (1) winner receives "[ARTWORK_TITLE]" by [ARTIST_NAME], an original physical artwork with an approximate retail value (ARV) of \$[ARV_USD], held in insured, bonded storage at [VAULT_LOCATION], together with the artwork's blockchain certificate (NFT). Winner chooses: continued vaulted storage ([INCLUDED_STORAGE_TERM] included), insured shipment to the winner (import duties/taxes are the winner's responsibility), or consignment for resale. Total ARV of all prizes: \$[ARV_USD]. Odds of winning depend on the total number of eligible entries received.
- 7. Winner verification and claim.** The provisional winner will be notified via the contact information associated with the winning entry and via the campaign page. The winner must complete verification within [CLAIM_WINDOW_DAYS] days of notification: control of the winning wallet (for purchase entries), identity

verification, sanctions screening, and an affidavit of eligibility (and tax forms where required). If the provisional winner fails verification or does not respond within the claim window, the prize passes to the next alternate in the pre-committed draw order. Sponsor may require a background release where required by law. Prize release on-chain is time-locked and payable only to the verified winner.

8. Taxes. All federal, state, and local taxes on the prize are the sole responsibility of the winner. For prizes of \$600 or more awarded to U.S. persons, Sponsor will issue IRS Form 1099-MISC and may require a completed Form W-9 before release.

9. General conditions. Sponsor may disqualify entries obtained by fraud, automation, or cap circumvention (multiple identities). If a campaign cannot run as described due to events outside Sponsor's control, Sponsor will award the prize from eligible entries received as of the interruption — the prize is always awarded. Entry constitutes acceptance of these Rules. Sponsor's records (the on-chain commitments and the frozen ledger) are final on entry counts and selection.

10. Publicity. Except where prohibited, the winner consents to publication of their wallet address, first name, last initial, and state/country for winner-announcement purposes, without further compensation. Winner identity beyond this is not published without consent.

11. Disputes; governing law. [GOVERNING_LAW_STATE] law governs. [DISPUTES_CLAUSE]

12. Winners list.
